Statement of intent

At North Cerney Primary Academy we ensure that teaching and learning meets the needs of all of the pupils. We ensure that appropriate provision is made for pupils who belong to vulnerable groups, this includes ensuring that the needs of disadvantaged pupils are adequately assessed and addressed.

Pupil premium spending focuses on supporting children to achieve their potential, aiming for all children to achieve at least age-related expectations. The use of the pupil premium funding aims to secure effective engagement from all pupils. This may require support in their basic physical needs, educational and emotional support and extracurricular activities.

Challenges
